



Terms and Conditions

These terms and conditions apply to the grant of cash up to the value of \$4,000 (ex GST)

Definitions

'**You**' means the organisation applying for a grant under Sydney Water's 2020 Community Grants program.

'Sydney Water' means Sydney Water Corporation (ABN 49 776 225 038).

Eligibility Criteria

In applying for this grant, you confirm that you meet the following eligibility criteria:

- you are a registered association, incorporated body or non-profit organisation, or a primary or high school, or have entered into an auspice arrangement with an eligible organisation;
- your project is an event or an activity that will take place within Sydney Water's area of operations;
- your event/activity is not sponsored by, or affiliated with, bottled water companies; and
- you do not have any religious, political or socially divisive objectives.

Any organisations or projects found to be ineligible for the grant will be excluded prior to the assessment process.

Assessment

A panel of Sydney Water staff will assess all applications. Sydney Water's decision will be final, and no correspondence will be entered into.

Your application must clearly demonstrate that the project has clear benefits for the local community. Examples of benefits for a local community are:

- helping to fix a community related problem
- improving relationships within the community.

Your project must also:

- promote Sydney Water's reputation through opportunities for positive community and media feedback; and
- be completed by 30 June 2021.

Terms and conditions for successful applicants

Your obligations for receiving the grant

You agree that, in exchange for receiving this grant, you must:







- carry out your project as described in your application and in accordance with all applicable laws;
- complete your project by 30 June 2021;
- complete and submit your acquittal report via the Good2Give platform by 31 July 2021;
- participate in social media and promotional media campaigns with, or for, Sydney Water relating to this grant; and
- at all times, act in a way that does not bring Sydney Water's reputation into disrepute.

Promotion and logos

Sydney Water's trademarks and logos belong to Sydney Water. You must obtain Sydney Water's written consent before using or publishing Sydney Water's trademarks or logos.

Payment

Payment of the grant is subject to satisfactory completion of due diligence by Sydney Water. You agree to Good2Give (ABN 32 089 603 314), administrator of the 2020 Community Grant funds for Sydney Water, conducting this due diligence on behalf of Sydney Water. This due diligence may include, but is not limited to, confirming information regarding your bank accounts, organisational structure and charity status.

Funds will be transferred electronically to your organisation by Good2Give using the bank account details provided by you to Good2Give after you have been informed that your application was successful.

Insurance

You are responsible for maintaining any insurance cover you require for your project.

Project cancellation or change

You must ensure that the grant is expended only as detailed in your application. You must give Sydney Water notice immediately if your project is cancelled or changed and seek to resolve the issue in good faith.

In order to maintain the integrity of this program, Sydney Water reserves the right in its absolute and sole discretion to require you to immediately return the grant to Sydney Water in the event that you do not comply with any terms and conditions contained in this document.

Repayment of grant to Sydney Water

Sydney Water has the right to ask you to repay some, or all, of your grant to Sydney Water if your organisation:

- does not follow your obligations identified above;
- changes or cancels the project without receiving Sydney Water's written agreement to do so; or
- you, or any individuals in your organisation, act in a way which brings, or could bring, Sydney Water's reputation into disrepute.









General

- You agree that the person accepting these terms and conditions on your behalf has authority to do so.
- The grant is provided to you and is non-transferable. If you want to transfer any, or all of the grant to a different organisation you must first obtain Sydney Water's prior written permission.
- Nothing in these terms and conditions constitute an exclusive arrangement or partnership, joint venture, fiduciaries, agency or an employer and employee relationship between you, your organisation and Sydney Water.
- These terms and conditions will be governed by and construed in accordance with the laws of the State of New South Wales and the parties irrevocably submit to the courts of New South Wales.
- You agree to receive communications from Sydney Water using the details provided on your application.
